#### Treasurers Report: \$19,500 deficit is due to:

*Income*: Unfortunately, due to Covid 19, only 1 season of basketball was played in 2020, hence the \$37,000 decrease in registration fees year on year. Prepaid registration fees of \$12,778 were received towards the cancelled winter season, and income has been deferred to 2021 Financial Year.

**Expenses:** coaches' equipment, balls and uniforms require replenishing of stock in alternate years, hence the increase of \$10,000 from 2019. Also due to covid 19, bad debts of \$1466 were written off in unpaid fees.
